Confidentiality Policy

The proper utilization of AMZ ADS Academy services involves the transfer of your data to Hosting Ukraine contractors.

By filling out the application form, you confirm that you're familiar with the list of your rights as a subject, following article 8 of the Law of Ukraine, "On the Protection of Personal Data". This list is available at this link:

1. GATHERING OF PERSONAL INFORMATION

- 1.1 During registration on the site, we ask you to provide the necessary personal information to the extent that is necessary for the requested services. We reserve the right to request additional personal information if necessary.
- 1.2 Cookies When you visit our website, we send one or more cookies to your device. Cookies are used in order to improve the quality of provided services and to save your preferences.
- 1.3 Visit Information When you access our site, our services automatically record data about your visit. These server logs may contain information such as the web request, IP address, browser type, language, date, and time of the request.
- 1.4 The hosting of AMZ ADS Academy can process personal information on servers in Ukraine and other countries. In some cases, users' personal information is processed outside the country of the user.

2. PROVISION OF ACCESS TO INFORMATION

- 2.1 We only share your personal information under the following limited circumstances:
- 2.1.1. We have your permission to do so. We require your explicit consent to transfer any confidential information

- 2.1.2. We have reasonable grounds to believe that accessing, utilizing, retaining, or disclosing such information is necessary to:
- 2.1.2.1. Comply with the legislation of Ukraine, including the provision of information at the request of individuals and legal entities, institutions, or organizations or state bodies that have the right to access said information in accordance with the legislation of Ukraine.
- 2.1.2.2. Investigate the potential violations of the Public Offer, which involves the provision of information about you in response to a properly executed lawyer's request with information about violations.
- 2.1.2.3. Protect against an immediate threat to the rights, property, or security of AMZ ADS Academy, its users, or the public, within the framework of the legislation of Ukraine.

3. PROTECTION OF INFORMATION

3.1 We take all necessary precautions to protect data from unauthorized access, alteration, or destruction. These measures include internal review of data collection, storage, and processing, as well as security measures, which include appropriate encryption and measures to insure the physical security of data to prevent unauthorized access.

4. ACCESS TO PERSONAL INFORMATION

4.1 We do our best to provide you with access to your personal data and either correct information if it is incorrect, or delete it at your request, unless its storage is required by law or for legitimate business purposes.
